#### **SECTION 4: First aid measures**

#### 4.1. Description of first aid measures

First-aid measures general

#### 4.2. Most important symptoms and effects, both acute and delayed

#### 4.3. Indication of any immediate medical attention and special treatment needed

Obtain medical attention if casualty has an altered state of consciousness or if symptoms do not resolve. Seek medical attention in all cases of serious burns. If there is any suspicion of inhalation of H2S (hydrogen sulphide). The casualty should be sent immediately to hospital. Immediately begin artificial respiration if breathing has ceased. Administer oxygen if necessary.

#### **Extinguishing media**

#### 5.3. **Advice for firefighters**

#### 6.1.2. For emergency responders

Protective equipment

: Small spillages: normal antistatic working clothes are usually adequate. Large spillages: full body suit of chemically resistant and antistatic material. if necessary heat resistant and insulated. Work gloves providing adequate chemical resistance, specifically to aromatic hydrocarbons. Gloves made of PVA are not water-resistant, and are not suitable for emergency use. Hand protection
